



Office of Agreements and Scientific Affairs (OASA)

- * OASA works to preserve and expand access to foreign markets for U.S. food and agricultural products
 - * Promotes an open, rules-based global trading system.
 - * Leads USDA in negotiation, monitoring, and enforcement of trade agreements.

Office of Agreements and Scientific Affairs (OASA)

- * Advises senior officials on strategies to prevent and address barriers to U.S. agricultural exports.
 - * Sanitary and Phytosanitary measures (SPS)
 - * Technical barriers to trade (TBT)
 - * Biotechnology and other emerging technologies
 - * Coordinates USDA's participation in the WTO and other international organizations.

WTO SPS and TBT Enquiry Point


WTO Created the SPS and TBT Enquiry Point:

- * The National Notification Authority (NNA) & the SPS and TBT Enquiry Point related to Agriculture required by the SPS & TBT Agreement are both housed in the FAS/OASA
- * FAS coordinates an *interagency process* for reviewing and responding to Agriculture Related SPS and TBT measures.

WTO SPS & TBT Measures

- * Once a measure is notified, FAS gets to work to determine whether the measure may have a negative impact on trade
- * If it does, we coordinate our response and prepare our "comments" via an interagency process.
- * Comments are drafted. We solicit input from across USG and industry, and coordinate the responses and submit a unified response to the notifying WTO member.

U.S. SPS & TBT Enquiry Point


* OASA collects foreign SPS & TBT measures, translates them, and solicits 200 industry groups and a dozen regulatory bodies to develop a formal U.S. position





Success Stories from FY12-15

From U.S. Comments & Negotiations:

- Vietnam removed phytosanitary certificate requirements for dehydrated potatoes: \$3 million
- China clarified and standardized record keeping requirements for non-compliant imports: \$5.8 billion
- ❖ Vietnam removed burdensome certificate requirements for bio-engineered food and food: \$185 million

From U.S. Comments Alone:

Indonesia removed requirements for lab test and production certificates for animal genetics: \$200,000

SPS/TBT System for Tracking Agriculture Regulations (STAR)

- Newsletter subscription to stay current on regulatory changes affecting your industry
 - Summary of notifications for the week by country, product, or key word.
 - * Auto-notification when full-text of the regulation is available.
- * Search engine to search WTO SPS/TBT notifications.
 - * Save time in reviewing, analyzing and drafting comments on foreign measures.
 - * Contribute earlier in the development of a coordinated U.S. strategy to address the problematic foreign measure.
- Reduce trade interruptions and stoppages before they occur.

Effective Comments

- * Risk Determination: Measures should be based on sound science and risk assessments, and be no more trade restrictive than necessary to achieve an appropriate (to the problem and source) level of protection
- * Harmonization: Does each notified measure harmonize with current Codex, OIE, IPPC or other international (including voluntary commercial) standards or does it implement standards that are more restrictive?
- More Stringent Standards have to be justified by a scientific assessment
- * Also, Members are encouraged to adopt Codex, OIE, IPPC standards International standards, guidelines, and recommendations in subject areas

Social Media and Int'l Trade

- Consumers more than ever want to know what's in their food
- * Fundamental misunderstanding of food additives role:
 - -Unaware of safety evaluations
 - -Unaware of benefits
 - -Unfamiliar with chemical names

Social Media and Int'l Trade

- * Consumer "Clean Eating" Movement to remove food additive ("chemicals") from food
 - * Blogospheres used to communicate includes misinformation and non-science based data
- Processed foods are the main target
- * Companies respond with a "all-natural" or clean label movement.

Outreach – Educating Trade Partners

- * Utilizing Independent Bodies Such as Codex and JECFA to set standards
- * Technical exchanges with Trade partners
- * Building relationships and creating capacity building projects




